2015 MEMBERSHIP/PARTICIPATION AGREEMENT

In consideration of Suskie Bassmasters allowing me to participate in events such as tournaments or any other events sponsored by Suskie Bassmasters I acknowledge and agree as follows:

1. I understand and acknowledge that fishing is a dangerous sport, the risks of which include though not exclusively, drowning, collisions in the water, and injuries from hooks and other fishing paraphernalia. I voluntarily assume responsibility for these risks, identified and not identified, and all risk of injury or death or damage to myself or my property or to others, including spectators and their property, arising from my participation in Suskie events.

2 I hereby release, discharge and agree to hold harmless and indemnify Suskie Bassmasters, guides, directors, the host, and tournament officials, and its partners, demands, actions, or rights of action which are related to, arise out of, or are in any way connected with my participation in this tournament/event, including specifically but not limited to the negligent acts of omissions of Suskie Bassmasters, its officers, directors, agents, and tournament officials, guides and its partners, and all other persons or entities associated with the tournament/event from any and all liability, claims, entities associated with the tournament/event, for any and all injury, death, illness or disease, and other damage or loss to property suffered by myself or others. In signing this document I acknowledge and agree that if anyone is hurt or property is damaged while I am engaged in tournaments/events I will have no right to make a claim or file a lawsuit against Suskie Bassmasters, its directors, officers, agents, the host, officials and all other persons or entities associated with the tournament/event even if they, or any of them, negligently caused the bodily injury, or property damage.

4. I have sufficient health, accident, and liability insurance to cover any bodily injury or property damage incurred by myself or others as a result of my participation in this tournament/event. If I have no such insurance, I represent that I am capable of paying for any and all such expenses and liabilities.

5. I have no past or present medication or psychological condition that might affect my participation in the tournament/event in such a way as to cause harm to myself or others.
